#### Crowdsourcing

Utilizing a crowd, or many people, to work on a project is known as crowdsourcing. In journalism, it refers to requesting more information from the general public in order to finish a story. When a

task is exceedingly large and requires many people, journalists typically do this. A newspaper can ask its readers to each read a portion of a lengthy document that has been made public, for instance, in order to verify the facts or hunt for specifics.

#### Live Blogging

When anything is happening live, as at a concert, a political rally, a sporting event, or a severe weather event like a snowfall, it is known as live blogging. Take a snowstorm as an example. Online newspapers will urge readers to submit photos of the snow, along with anecdotes about how long it has affected them. Another type of citizen journalism is called "witnessing," and it involves people who are there for abrupt, dramatic events and who document what they are seeing and hearing. When a witness captures moments from the "right place at the right time," they frequently produce fragments or snatches of unintentional journalism. Professional outlets' live blogs require quick, ongoing material updates.

Being the busiest road, there is often a danger of accidents. Many a times children have also been stung by vehicles.
